PROGRAM: Las Mañanitas offers a 2 day (Th/F), 3 day (MTW), and 5 day (MTWThF) Morning Program from 8:50am to 12:50pm (organic vegetarian snack and hot lunch included) and a 2 day (Th/F), 3 day (MTW), and 5 day (MTWThF) Afternoon Program from 1pm-4pm (organic hot vegetarian snack included) The 5 day Morning Program is available to children who are 4 years old by December 1, 2020. The 5 day Afternoon Program does not have the same age criteria as the 5 day Morning Program Each program has a community of 12 children and 3 teachers. There is also an additional optional Summer Program directly after the end of our regular school year. Students do not have to be enrolled in the Morning Program to participate in the Afternoon Program. Students in the Morning Programs are welcome to participate in the Afternoon Program in addition to the Morning Program. Our school year begins August 17, 2020 and ends May 28, 2021.

TUITION: Yearly tuition for the 2 day Morning Program is \$5,620. Yearly tuition for the 3 day Morning Program is \$8,530. Yearly tuition for the 5 day Morning Program is \$14,150. Yearly tuition for the 2 day Afternoon Program is \$4,780. Yearly tuition for the 3 day Afternoon Program is \$7,180. Yearly tuition for the 5 day Afternoon Program is \$11,960. For convenience, the yearly tuition is divided into ten monthly installments. Payment is due on the first day of each month beginning in August. Limited need based scholarships are available. Please see the Scholarship Application to view the income criteria. Preschool For All funds may also be available for families who meet PSFA criteria (a child who turns 4 before December 2, 2020, is enrolled in the 3 or 5 day Morning Program, and who has proof of SF residency).

HOLIDAYS: Las Mañanitas follows the SFUSD academic calendar. A complete and final list of the observed holidays, professional development days, and vacations will be provided in May 2020.

APPLICATION PROCESS: Children who are 2 years 9 months by September 1, 2020 are eligible to apply. We try to balance our program by age, gender, and level of Spanish proficiency to the best of our ability. Please submit this application with a family photo and a non refundable \$40 application fee (checks payable to 'Las Mañanitas') to the address listed below.

Applications are due by February 22, 2020 with all applicants being notified beginning March 9, 2020.
